Legislative Changes Affecting Adult Care & Family Care Homes

Session Law 2011-249/House Bill 397 *Effective June 23, 2011*

Penalties and Remedies Concerning Health Facilities

- Provides two classifications of a Type A violation—Type A1 violation and Type A2 violation.
- New language in the definition of a Type B violation.
- Requires a facility to provide an immediate 'plan of protection' when a violation (Type A1, Type A2, Type B) has been identified. The plan of protection must show how the facility will immediately correct the violation in order to protect the residents from further risk or harm. The plan of protection will be provided to the surveyor(s) while they are still at the facility, before the exit conference.

Session Law 2011-272/House Bill 677 *Effective October 1, 2011*

Discharge of Adult Care Home Residents

- Establishes a new Adult Care Home Resident Discharge Team consisting of the local Department of Social Services, the Local Management Entity (LME), and the Regional Long Term Care Ombudsman (if requested by the resident). The discharge team is responsible for assisting facilities with finding placement for a resident if at the time of the 30 day discharge notice the discharge destination is unknown or not appropriate for that resident.
- Requires facilities to obtain (upon admission) the name of an individual that the resident wishes to receive a copy of the 30 day notice of discharge in the event that the resident is discharged from the facility.
- Provides details on the requirements of a facility to provide a safe and orderly discharge, the process of appealing a discharge notice, and reasons that a resident may be discharged from a facility.

Session Law 2011-258/House Bill 808 *Effective October 1, 2011*

Waive Annual Inspections Based on Star Ratings and Informal Dispute Resolution (IDR)

- Allows facilities that have achieved the highest star rating (4 stars) to be inspected once every two years instead of annually.
- Establishes an Informal Dispute Resolution (IDR) process by which a facility may dispute deficiencies and violations cited during an inspection.

Session Law 2011-99/House Bill 474 *Effective May 31, 2011 (To be phased in through 2013.)*

Infection Control Standards and Continuing Education, Training & Competency of Medication Aides

- Requires facilities to develop and update policies and procedures related to safe infection control practices. Facilities will be inspected to ensure compliance with the federal Centers for Disease Control and Prevention guidelines.
- States that DHHS will develop guidelines for reporting suspected communicable disease outbreaks.
- Establishes additional requirements for medication aide training and competency evaluation over the next two years.
- Establishes a required training course for adult care home supervisors on infection control.
