PUBLIC NOTICE

Approval Sought for a 144-Bed Behavioral Health Hospital in Greenville

RALEIGH — Pitt County Memorial Hospital Inc. and Acadia-Vidant Joint Venture LLC have filed a certificate of need application with the North Carolina Department of Health and Human Services to develop a new 144-bed behavioral health hospital consisting of 120 inpatient adult psychiatric beds and 24 inpatient child and adolescent psychiatric beds. The facility — Eastern North Carolina Behavioral Health Hospital — will be located in Greenville.

Seventeen of the beds will be new beds either through Policy PSY-1 (10 beds) or new additional beds (seven beds). The remaining beds are existing licensed inpatient psychiatric beds in the Vidant Health system that will transfer ownership and be relocated.

The project is expected to cost \$63.9 million and would be completed in October 2022.

A public hearing for this project will be held Sept. 15 at 1 p.m. in the Eugene James Auditorium on the second floor of the Pitt County Administrative Office Building, 1717 West 5th St., Greenville.

Anyone may file written comments concerning this proposal. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5 p.m. on Aug. 31.
